

CONDITIONS OF RELEASE

Every Defendant utilizing the services of SBI Bail Bonds of PA, LLC. must follow all conditions listed below. Failure to do so may be considered grounds for revoking bail.

1. Attend **ALL** court dates.
2. If a court appearance is missed, then the Defendant must contact SBI Bail Bonds of PA, LLC. In most cases, we may be able to reschedule the date. Failure to contact SBI Bail Bonds of PA, LLC. will result in the Defendant being considered a fugitive and the case will be assigned to our Fugitive Recovery Unit.
3. The Defendant is required to check-in by telephone and/or in person once a week until his/her case has been disposed of in the court system. The telephone number, address and day for your check-in, are as follows:

4. The Defendant is required to notify SBI Bail Bonds of PA, LLC of any new address changes.
5. The Defendant must notify SBI Bail Bonds of PA, LLC of any change in address and/or telephone number.
6. The Indemnitor must notify SBI Bail Bonds of PA, LLC if the Defendant is re-incarcerated or gets sentenced on a case for which the Indemnitor has signed.
7. The Defendant must notify SBI Bail Bonds of PA, LLC if he/she retains an Attorney.
8. It is the responsibility of **BOTH** the Indemnitor and the Defendant to pay any premium balance due. This is the case even if the Defendant becomes re-incarcerated.
9. The Defendant will not be permitted to leave the state of incarceration, except for residing in another state or a reason to be approved by SBI Bail Bonds of PA, LLC.
10. This Defendant may be required to visit an office maintained by SBI Bail Bonds of PA, LLC. during a thirty (30) day time period for a personal check-in. The amount of visits to be determined by SBI Bail Bonds of PA, LLC.
11. The Defendant understands that he/she is subject to random visits at home or work by an agent of SBI Bail Bonds of PA, LLC.

SBI Bail Bonds of PA, LLC. reserves the right to apply with the court where the bond was posted, to have the bond revoked and/or request a warrant to be issued for the Defendant's arrest. If the Defendant misses a scheduled court date, hearing or fine payment, the Indemnitor and the Defendant will be responsible for any and all costs incurred by SBI Bail Bonds of PA, LLC. for the re-arrest or voluntary surrender to SBI Bail Bonds of PA, LLC. or any arresting authority. Collateral will not be returned unless a certified copy of the bond discharge or exoneration is provided to SBI Bail Bonds of PA, LLC. It is understood that these conditions **DO NOT** supersede any terms and conditions that may be imposed by the court. These conditions are supplements to the courts conditions.
